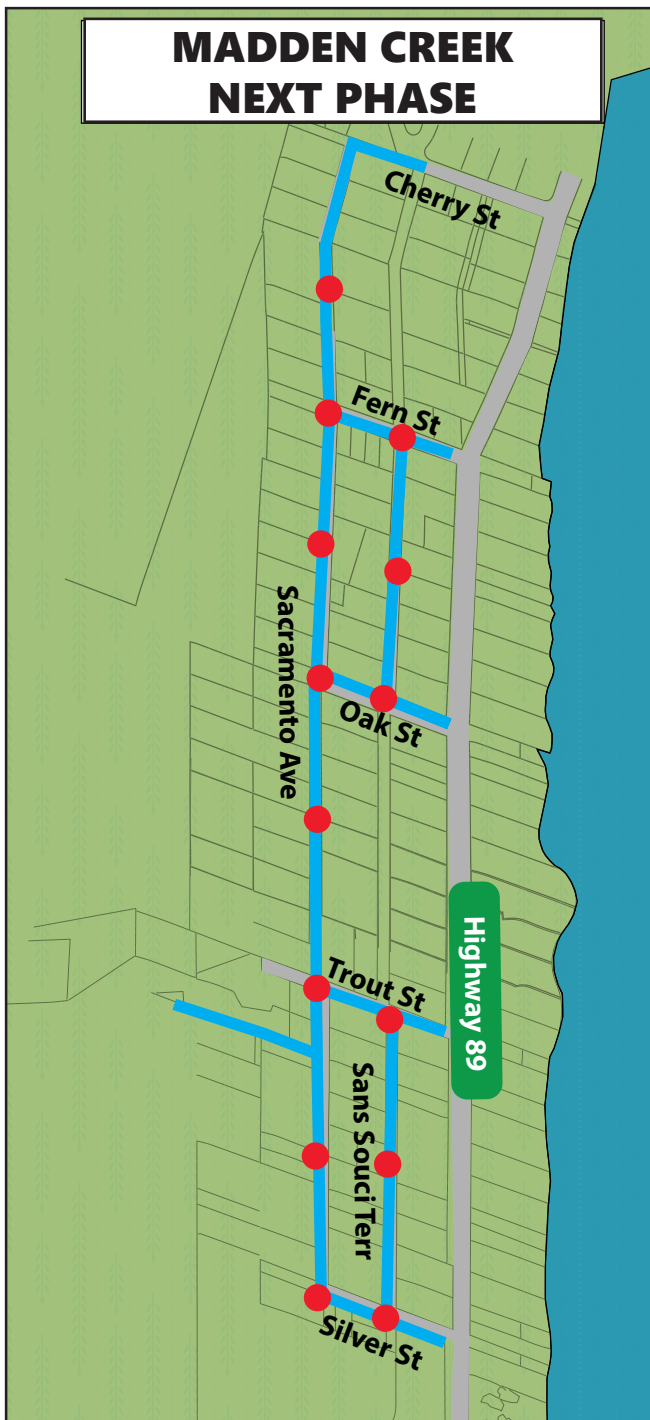

## Madden Creek Water System Reconstruction 2025 Construction Substantially Complete

Next Phase Will Focus on Remaining Neighborhood Streets

**2025 RECAP:** This summer, contractors for TCPUD completely rebuilt the water system within the Highway 89 right of way from Fern Street to South Street, and replaced portions on Sacramento Avenue and Sans Souci Terrace south of Fawn Street. This work included:

- Building 5,356 feet of 8-inch water main and 394 feet of 12-inch water main.
- Installing 10 fire hydrants.
- Installing 56 new water meter pits for future meters.

**COMING UP IN FUTURE PHASES:** The next phase of the project will mark the completion of this crucial investment to upgrade and modernize your water system.

Construction during the next phase will focus on water main upgrades on Fern, Oak, Trout, Silver, Fawn, Sacramento, and Sans Souci. This project will install:

- 8,105 feet of new larger diameter water mains - shown as blue lines on the map.
- 14 new fire hydrants in locations previously without hydrants - shown in red circles on the map.
- Water meters for all Madden Creek customers. More information about metered billing will be coming soon.

**WHEN:** Construction is scheduled to restart in 2026 and may continue into 2027.

## West Shore Trail Reconstruction Update



TCPUD recently reconstructed 2.4 miles of the iconic Dianne Feinstein West Shore Tahoe Trail between Sunnyside and Idlewild Way.

Originally built in the 1970s, the trail has benefited from TCPUD's regular maintenance, but after nearly 50 years, a full reconstruction was necessary.

The project improved:

- Pavement integrity and safety
- Slope and alignment for a smoother ride
- Visibility for pedestrians and vehicles
- ADA compliance
- Drainage and erosion control

## West Lake Tahoe Water Treatment Plant Now Delivering Water



We're thrilled to announce the new West Lake Water Treatment Plant is now delivering water to the distribution system.

The plant is initially delivering water to customers in the McKinney/Quail system between Homewood and Tahoma.

In the future, the plant will deliver water to over 2,400 customers on the west shore from Timberland to Tahoma.

The new plant replaces a temporary seasonal facility and provides year-round water supply sourced directly from Lake Tahoe.

The project strengthens the public water supply, improves fire protection, and builds long-term resilience across TCPUD's interconnected water systems.
