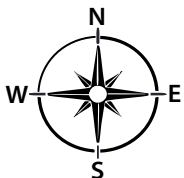

West Shore Trail Reconstruction Begins in May

\$4.8 Million investment will improve trail experience for all users.

WHAT: Contractors for TCPUD are planning in May to begin work on the West Shore Trail Reconstruction Project. The project will reconstruct 2.4 miles of trail between Sunnyside and Blackwood Creek.

The project will improve:

- Pavement integrity and trail condition
- Slope and alignment for a smoother ride
- Visibility for pedestrians and vehicles
- ADA compliance
- Drainage and erosion control

WHY: Originally built in the 1970s, the West Shore Trail has benefited from TCPUD's ongoing preventative maintenance, but after nearly 50 years, a full reconstruction is necessary.

WHEN: Construction is scheduled to start with tree removal in the beginning of May and last through October 2025.

WHAT TO EXPECT: A number of trees along the highway will be removed at the start of the project due to safety and conflict with the trail alignment.

During peak construction, the trail may experience full closures. However, on weekends and from June 28 to July 13, the trail will either remain open or have detour options available.

Neighbors may experience associated construction activity and noise. Access to properties will be maintained, though brief restrictions may occur. Crews will work to minimize disruptions.

Madden Creek Water System Reconstruction in Homewood This Summer



TCPUD is continuing its long-term investment in drinking water reliability and fire suppression improvements with construction of Phase Three of the Madden Creek Water System Reconstruction Project.

Construction is scheduled to begin in late April and will continue through Fall 2025.

Phase Three of the project will focus on rebuilding the aging water system within the Highway 89 corridor in Homewood, including the installation of 5,750 feet of new water main and 10 new fire hydrants.

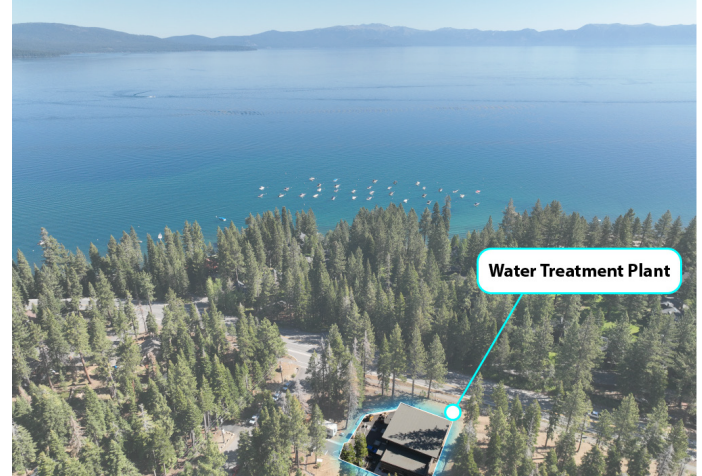
Once complete, the modernized system will be capable of delivering reliable drinking water and critical fire flow for this west shore community.

Progress on West Lake Tahoe Water Treatment Plant Continues



Work continues to bring the new West Lake Tahoe Regional Water Treatment Plant online, with full operation expected in Summer 2025.

The new water treatment plant replaces a temporary facility in Chambers Landing. The new plant will provide a permanent, drought-resistant drinking water source from Lake Tahoe and support improved fire suppression capacity.
